Earning the APICS CPIM certification demonstrates mastery of an organization's internal operations and an in-depth understanding of materials management, master scheduling, forecasting, production planning, and how these topics apply across the extended supply chain.

In addition to the guidance that you will receive in the classroom, you will also receive the APICS CPIM Learning System. The Learning System provides access to both printed and digital materials. The online platform also includes learning activities, a personalized study experience, microlearning, and convenient access to reading materials.
